Please now read the Terms and Conditions below. Paragliding Tuition cannot take place without your signature in the box at the end of this form.

Terms and Conditions

1. You can take your Taster Day up to six months after the date of booking. Your Elementary Pilot and Club Pilot courses are valid for six months after the first day of training.
2. Your EP course will take at least 3 days and up to a maximum of 7 days. Your CP course will take at least 5 days and up to a maximum of 10 days. If you have had the maximum number of training days for your course you will have to pay the daily rate.
3. We can reschedule your booking given sufficient notice or due to unsuitable weather for your course at no extra charge. Refunds are not available.
4. Failure to give us sufficient notice postponing your day's tuition will result in the loss of that day's fee.
5. Minimum age for Taster Days is 14. Minimum age for other courses is 16. If you are under 18 years of age, a signed letter of consent is required from your parent or guardian. If you are under 16 a parent or guardian must be present during training.
6. You may only take one of the Special Taster Day Deals at a time.
7. If your Taster Day is not finished due to you arriving late, choosing not to finish or your aptitude you will have to pay a surcharge to finish on another day.
8. All persons paragliding in the UK must be members of the BHPA. Introductory membership of the BHPA is included in the cost of the Taster Day and will be arranged during training.
9. Paragliding is inherently dangerous. **Accidents can happen** even within the training environment where every effort is made to reduce the risks.
10. When under tuition, the Duty Instructor's decision is final.
11. It is illegal to be in control of any aircraft, including a paraglider, when intoxicated by alcohol or drugs. *Flying Frenzy* PARAGLIDING Ltd. reserve the right to terminate your instruction at any time if we consider you to be unfit or your conduct unsafe.
