We can reschedule the booking given if given sufficient notice or due to unsuitable weather 3. Failure to give us sufficient notice postponing the day's tuition will result in the loss of that day's fee. 4. Refunds are not available. 5. Minimum age for Taster Days is 14. Minimum age for other courses is 16. If this voucher is for anyone under 18 years of age, a signed letter of consent is required from their parent or guardian and if they are under 16 a parent or guardian must be present during training. 6. If the Taster Day is not finished due to the student's late arrival, their decision not to finish or their aptitude then no refunds will be given or a surcharge will be charged in order to finish on another day. 7. All persons paragliding in the UK must be members of the BHPA. Membership is included in the Taster Day course fees and arranged on the day of training. 8. Paragliding is inherently dangerous. Accidents can happen even within the training environment where every effort is made to reduce the risks. 9. When under tuition, the Duty Instructor's decision is final. 10.
